

Chapter 7

Agencies and Parties Consulted

Notification that an EIS was to be prepared, known as an EISPN, was published in the OEQC *The Environmental Notice* on April 23, 2017 to solicit input on topics of interest. *Table 7-1* identifies those agencies, organizations, and individuals that were consulted as a stakeholder, received a presentation, provided input on project design or are part of an ongoing consultation effort throughout the environmental review process. Comments received during the 30-day EISPN public response period are listed, whether via letter, email, or received during a community meeting. The comments, along with the response provided, are reproduced in this chapter. Availability of the Draft EIS will be provided to those listed in conjunction with the publication of the Draft EIS in *The Environmental Notice*. Publication initiates a 45-day public comment period for the Draft EIS.
