DISCUSSION:

Jason Takaki, Program Administrator, Capital Projects Division, gave the report.

Chair Andaya inquired if the trend has affected the execution of projects or the budget.

Mr. Takaki replied that in the first quarter the trend over the years show minimal change. During the first quarter, the staff is completing and executing fourth quarter projects from the prior fiscal year. Mr. Takaki mentioned with the adoption of Indefinite Delivery, Indefinite Quantity Contracts (IDIQ) has allowed the BWS to contract small work orders without the need for bids.

Chair Andaya asked if the budget execution amounts are awarded or encumbered.

Mr. Takaki responded that the amounts are encumbered.

Chair Andaya inquired if the completed projects listed on the table presented reflect contracts that are completed by quarter.

Mr. Takaki replied that each quarter should reflect completed projects.

Chair Andaya asked if at the end of each fiscal year the projects completed would match the total amount awarded or are there carryovers from previous years.

Mr. Takaki responded that majority of the BWS's projects take multiple years to complete.

Manager Ernest Lau added that completed projects could be from previous fiscal years.

Chair Andaya commented he looks forward to seeing progress.

Board Member Ray Soon commented that the total budget for ongoing projects has nearly doubled to \$372 million.

Mr. Takaki agreed stating that as projects are completed more projects are added to the overall workload.

Board Member Soon inquired what hinders the BWS from completing projects in a shorter timeframe?

Mr. Takaki replied that the BWS struggles with having sufficient staff to process all the paperwork to close out the project. In addition, the projects are not simple and at times a quick resolution to resolve issues may not be possible.

Chair Andaya and Board Member Soon asked if the BWS would be able to provide a progress report for all of the outstanding design and construction projects which could track the progress of projects from beginning to completion.

Manager Lau responded that the BWS would work on a summary report that provides performance metrics on project execution and completion.

Chair Andaya stated that if there is anything that the Board would be able to assist with, the Board is available to work with the BWS as a team. He expressed his appreciation to the BWS.




Total Operating Expenditures - \$54.3 As of September 30, 2021 (millions of dollars)

Subject: Status Update of Groundwater Levels at All Index Stations

There were four aquifer index stations in low groundwater condition for the production month of October 2021. Waialua and Pearl City are in Caution Status. Kaimuki and Punaluu are in Alert Status. The monthly production average for October 2021 was 143.82 million gallons per day.

The Board of Water Supply rainfall index for the month of October 2021 was 74 percent of normal, with a 5-month moving average of 79 percent. As of November 2, 2021, the Hawaii Drought Monitor showed a gradation from abnormally dry to moderate drought conditions on the leeward side of Oahu from Honolulu to Ka'ena Point, and severe drought conditions on the leeward coast from Ewa Beach to Makaha. The National Weather Service (NWS) is forecasting below-normal precipitation for November 2021. However, according to NWS, La Niña conditions are now present across the Pacific Ocean. The transition from drier conditions in autumn to wetter conditions in winter across the Hawaiian Islands is consistent with the impacts of La Niña conditions. Therefore, NWS is forecasting above normal precipitation from December 2021 to Spring 2022.

Most monitoring wells exhibited stable to slightly decreasing head levels for the month, likely due to increased pumping during the summer and fall dry season. Average monthly Production for October 2021 was higher than the previous year and the 5-year monthly average.
