DISCUSSION: Raelynn Nakabayashi, Executive Assistant I, Executive Support Office, gave the report.

Chair Andaya asked if the BWS is sacrificing any projects by changing, deferring, or canceling any project listed in Budget Amendment #2.

Ms. Nakabayashi replied items listed under Budget Amendment #2 are both project deferrals and a reduction in the level of funding, commensurate to the amount required in that Fiscal Year. Regarding the deferred projects, like Pipeline Condition Assessment or Waihe'e Line Booster, they were deferred to a future year because the projects were not ready to begin. These were deferred due to the timing of the permitting or design and were not sacrificed for other projects. The Non-Potable Irrigation Conversion for Keehi Lagoon Beach Park project is being funded

by the City and County (C&C) of Honolulu, therefore funding is not needed. Projects in Budget Amendment #2 that were deferred were because the BWS was not ready to pursue the projects in FY21; the projects that were ready to proceed were contracted and our funding needs were met by balancing the funding available.

Chair Andaya inquired if Lanikai Water System Improvement project listed in Budget Amendment #1 was added due to a water main break.

Manager Lau responded that the original purpose of the Lanikai Water System Improvement project is due to the frequent water mains breaks in water system. The C&C planned to construct a new roundabout and major street improvements in the area and the BWS decided to begin the Lanikai Water System Improvement project before the C&C began work. Manager Lau mentioned that although the work in Lanikai has its challenges due to traffic issues, the BWS continuously works with the community to try and mitigate the extent of the traffic impacts.

Board Member Jade Butay asked if money was not an object what would be the funding gap between projects and resources.

Ms. Nakabayashi replied that the total budget remained the same in the amount of \$201,587,500 which had been increased by \$30 million by Budget Amendment #1.

Manager Lau also replied stating that Budget Amendment #1 allowed projects to be reprogramed in the Fiscal Year 2021 budget. He explained that when preparing the Operating and Capital Improvement Project (CIP) budget Ms. Nakabayashi identifies the total revenue for the year and sources of funding which include issuing revenue bonds or state revolving funds (SRF) loans. Manager Lau mentioned that since the pandemic the BWS has encountered higher prices for materials. If federal stimulus funds were made available, a budget amendment to the increase the CIP would have been required. Manager Lau stated that the BWS operates with the funds in the adopted budget.

August 23, 2021

Ms. Nakabayashi added that in consideration of the projects that the BWS wishes to pursue, the BWS requires not only funding for the projects, but also growth in its operating resources, to reach its target of replacing 21-miles of pipeline annually. The BWS is on target to reach that goal with the water main replacement schedule, but it must fill engineer and planner positions to complete the work. The addition of funds to the CIP alone, without growth in engineering positions, would not achieve our goals.

Board Member Butay mentioned the reason he asked about money not being an object is that at times external entities do not understand the challenges facing department's ability to deliver and obstacles beyond the department's control.

Manager Lau agreed with Board Member Butay's statement. Some of the obstacles that the BWS faces are permit issues and increases in material costs. He expressed his appreciation to the Board for the provision within the resolution that gives the BWS the flexibility to fund critical projects that are ready each year.

Board Member Butay inquired if the BWS has an estimate on how much of the water mains are affected by sea-level rise.

Manager Lau responded that the BWS worked with the Water Research Foundation to develop an estimate but could not provide Board Member Butay the exact numbers at that time. He stated he would check with the Water Research Foundation project in regards to sea-level rise and report back. He mentioned that a lot of the pipelines affected by sea-level rise are along coastal highways under the jurisdiction of the Department of Transportation (DOT). The BWS is will collaborate, discuss, and work with the DOT to address these issues.

Board Member Butay stated the estimate to relocate coastal highways would be approximately \$15 billion, Kamehameha Highway is in the top five.

Manager Lau agreed with Board Member Butay commenting that acquiring property and rights of way will be challenging and expensive. The BWS has pipelines suffering from corrosion throughout the windward areas, Punaluu and Kaawa that are along the coastal highways. The BWS continues to look into different alternatives and solutions, and weigh out the pros and cons of relocating, redesigning, and/or restoring the water infrastructure.

Chair Andaya asked there were any further questions. Hearing none, Chair Andaya thanked Ms. Nakabayashi for the report.



DISCUSSION: Chair Bryan Andaya, Manager Ernest Lau, and Deputy Manager Ellen Kitamura gave the report.

Chair Andaya opened the discussion by stating that due to the astronomical COVID-19 case counts the BWS has decided to take some action and limit the number of people in the Board Room. However, Chair Andaya wanted to allow the Board Members to discuss and give feedback.

Manager Lau asked Deputy Manager Ellen Kitamura to review the COVID-19 trend information from the DOH website.

Deputy Kitamura shared the following current data trends from the Department of Health COVID-19 website (<u>https://health.hawaii.gov/coronavirusdisease2019/current-situation-in-hawaii/)</u>:

- Hawaii COVID-19 Case Counts
- Map of Oahu showing the geographic location of the cases in the past 14 days
- Map of Oahu showing the geographic location of the percent positive tests in the past 14 days
- Epidemic Curve (epi-curve)
- Hawaii COVID-19 Vaccine Summary

Manager Lau commented the epi curve is concerning. The contagious Delta variant continues to spread across countries and affects both the vaccinated and unvaccinated. He stressed the importance of being careful amid the pandemic. He expressed his appreciation for the vaccine that has been made available but is concerned about the efficacy of the vaccine

over time wanes, therefore feels that the COVID-19 booster shot will be an important factor as time goes on.

Chair Andaya thanked Deputy Kitamura for the statistics. He believes that everyone attending the meeting understands the seriousness of COVID-19. The reason he asked to open discussions on Board meeting protocols during the pandemic is that the time, manner, and place of Board meetings should be with the purview of Board Members. Chair Andaya agreed to the BWS policy that Manager Lau had put in place, limiting the Board room inperson capacity. However, it was important to him to allow the Board Members to share any feedback. Chair Andaya stated that there are options and alternatives to accommodate in-person Board Members and attendees for Board meetings during the pandemic. He suggested moving the meeting to a bigger room on the facility or another city facility to comply with both state and city mandates.

Manager Lau asked if Chair Andaya would like to continue the discussion in the September Board meeting to give the opportunity to other Board Members who were not in attendance.

Chair Andaya agreed to include Update on the Board of Water Supply Board Meeting Protocols Under Elevated COVID-19 Conditions on the September agenda.

Manager Lau explained that the BWS has been working on minimizing the amount of BWS staff in the Board room to allow more Board Members to attend in person. The BWS is also looking into using a bigger room such as the Engineering Conference room on campus that will allow board meetings to be conducted in-person, remotely, and permit the public to view the live stream of the meeting.

Vice Chair Sproat expressed her appreciation to everyone who has helped to make Board meetings accessible. The BWS has led the way to safely allow public participation. She recalls that before the pandemic the BWS began offering the public the opportunity to testify remotely. Vice Chair Sproat thanked Manager Lau, Ms. Nakabayashi, and everyone that make it possible for the BWS to conduct public government business while still allowing the community and rate payers to participate.

Vice Chair Sproat shared her perspective as a Board Member and as a mother. She is grateful that joining meetings online is an available option because her children are ineligible for the vaccine. Therefore, her family is being especially cautious, given the impact on native Hawaiians. Vice Chair Sproat stated she understood the diversity of perspectives on the Board but due to the severity of the pandemic, she would prefer to have the option to join Board meetings remotely.

Vice Chair Sproat requested that in the September Board meeting that the BWS staff be given the opportunity to share their concerns or issues during

this pandemic. She expressed her gratitude to all the frontline workers that assist in preparing for a Board meeting and would like feedback.

Board Member Anthony agreed with Vice Chair Sproat's comment regarding family, which he felt is important to recognize due to different risks factors in each family. As part of the COVID-19 Pau campaign and working to track information, some of the information that Board Member Anthony has learned is people's ability to be comfortable in the space provided and the environment which calls for little changes such as the numbers of participants. He applauded and thanked the BWS for how well Board meetings are conducted remotely and in person.

Board Member Anthony commented regardless of which platform the BWS uses it's important to stay connected with the public and encourage public input without prejudice and time restraint. He stated that the BWS must try as much as possible to stay engaged with staff and the community, and continue the good work that the BWS has been doing throughout the years.

Board Member Butay stated that he serves on over 30 Boards and Commissions due to his position. Therefore, appreciates being given the option to join meetings virtually. He expressed his concern in regards to the pandemic and appreciated the option to hold online Board meetings.

Vice Chair Sproat suggested looking into training opportunities that could assist participants to get the best experience possible.

Board Member Anthony mentioned checking with participants to see if proper equipment is available. He commented that having proper equipment such as hearing/speaking devices and lighting could help with the experience. Board Member Anthony offered to share virtual best practices and assist with media.

Manager Lau accepted Board Member Anthony's offer and thanked Vice Chair Sproat and Board Member Anthony for their suggestions.

Chair Andaya thanked all the Board Members for their feedback and offering their expertise. He stated that the discussion will continue when all Board Members are present where a decision can be made.

STATUS UPDATE OF GROUNDWATER LEVELS AT ALL INDEX STATIONS

Subject: Status Update of Groundwater Levels at All Index Stations

There were three aquifer index stations in low groundwater condition for the production month of July 2021. Kaimuki and Waialua are in Caution Status. Punaluu is in Alert Status. The monthly production average for July 2021 was 150.86 million gallons per day.

The Board of Water Supply rainfall index for the month of July 2021 was 69 percent of normal, with a 5-month moving average of 88 percent. As of August 3, 2021, the Hawaii Drought Monitor showed abnormally dry conditions on the island of Oahu; with moderate drought conditions on the leeward side of the island from Honolulu to Haleiwa; and severe drought conditions along the leeward coast from Pearl Harbor to Makaha. The National Weather Service (NWS) is forecasting below normal precipitation for August 2021. Below-normal precipitation is likely through November, due to current ENSO-neutral conditions, with increasing probability of La Niña conditions by winter.

Most monitoring wells exhibited decreased head levels for the month, likely due to increased pumping during the summer dry season. Average monthly Production for July 2021 was higher compared to the previous year and the 5-year monthly average.
